REASONS FOR ALLOWANCE

Claims 1, 3, 4, 7, 11, and 12 are allowed.

The following is an examiner's statement of reasons for allowance: While the prior art discloses TPM sensors (Mittal et al., US Pat. 5,818,731), POS terminals (Pollock et al., US Pub. 2008/0222004), as well as TPM sensors used in a network (Bruinsma et al., US Pub. 2010/0201528), none of the prior art of record disclose or suggest, alone or in combination, using a server or network to connect a TPM sensor to a POS terminal as claimed.
